The Relias Opioid Risk Solution computes risk using algorithms based on automated predictive models that become more accurate over time.


Example: This view shows the last 12 months of claims data for members in the state that have filled an opioid prescription in the last 90 days, including high level summaries information for the spend, hospital admissions, opioid Rx spend, ED visits, and SUD spend.
