The Outcome and Assessment Information Set (OASIS) Training Bundle



The Challenge

Since its debut in October. 2000. the Outcome and Assessment Information Set (OASIS) document has become the Magna Carta of the home health industry-no other document is as important as the OASIS assessment. The OASIS is a group of data elements developed by the Centers for Medicare and Medicaid (CMS). These data elements represent core items of a comprehensive assessment for an adult home care patient. They form the basis for measuring patient outcomes and determining agency reimbursement.

The OASIS data elements drive Medicare reimbursement. Spending arowth for freestanding home health care agencies accelerated in 2015, increasing 6.3 percent

to \$88.8 billion, according to the CMS National Health Expenditures 2015. The OASIS elements also drive publicly reported outcomes measures and now value-based purchasing. Inattention to the OASIS assessment and surrounding processes can sink an agency. Staff training on the OASIS data element completion and maximizing interrater reliability are critical factors to agency success.

Standardized OASIS training, based on a solid foundation of CMS guidance and interpretation, as well as knowledge of the home health industry opportunities and challenges, is key to OASIS accuracy and increased inter-rater reliability. To ensure agency success, each clinician responsible for completing any of the OASIS data elements must know and have the

same understanding of the OASIS data element collection rules and interpretations. As one agency administrator said, "we don't want to answer one of the OASIS questions incorrectly,



but answering it inconsistently is even worse."
