Assessments combined with staff development and training can significantly impact four of the most important drivers of opioid misuse:

- **Opioid risk identification:** identify both current opioid dependence and those with increased potential of opioid dependence
- **Screening for substance misuse and key addiction behaviors:** screen for behaviors and other substance misuse that contributes to dependence
- **Proper opioid prescribing:** ensure providers are following proper use of opioids and best prescribing practices to reduce the likelihood of opioid misuse
- **Multimodal treatment for pain:** encourage use of alternative pain management to decrease reliance on opioids

Providers whose habits are identified as outside best practices are assigned a pre- and post-assessment and a series of courses to address the knowledge gaps, including a simulation to demonstrate growth.
